The Preston Township Board of Supervisors held their July 7, 2022 Board meeting at 9:00 a.m. on Thursday, July 7, 2022 at the Township Municipal Building. Alan Jones, Chair, called the meeting to order. Alan Jones, and Stephen Brown Board were present. James C. Neu, Jr. was absent. The Pledge of Allegiance followed.

Minutes of the June meeting were read. Motion to approve the minutes as read by Stephen Brown, second Alan Jones. Motion carried.

Invoices for the month were reviewed. Motion to pay expenses and approve the payrolls by Stephen Brown, second Alan Jones. Motion carried. Expenses totaled **\$65,673.75**. Payrolls totaled **\$22,960.74**.

Marissa McAndrew, Township solicitor, on behalf of the Board will petition the Wayne County Court of Common Pleas to remove the restrictive covenant for future use of the ballfield. It is not the intent of the township to sell the entire ballfield. By removing the covenant the township can add land to the depot property for a septic system. The land addition will allow the township to offer the depot for sale.

Steve Brown reported grading is continuing. Three more loads of liquid calcium should almost complete the applications.

There is nothing new on the ARV issue. Comments were made on placing a referendum on the ballot. Catherine Puchalski Adamitis, stated she was born and raised in Preston Township, she still owns property here and she is totally against dual use roads, Mrs. Adamitis asked what is the benefit of ATV dual use roads to the community. Bill Farr said he paid \$50.00 for an ATV sticker, rode the trail once and would not ride it again.
